Other tasks

All collected data were compiled to a comprehensive report (Annual Employee Satisfaction Survey, 2022) and circulated among the members of SSCQA. Lastly, it was handed over to the Vice Chancellor, Sabaragamuwa University of Sri Lanka.
- ii. In order to facilitate the student assessments effectively by giving examination marks on time, awareness programme for the quality assurance coordinators was conducted on online paper marking gateway which is developed by the Faculty of Agricultural Sciences.
- iii. Exit Interviews for the employees who left the University during the year 2022 were done and the outcome was communicated to the SSCQA.
- iv. The organogram of CQA has been amended including the new faculty, Faculty of Computing.
- v. 'Outreach Unit-SUSL" was established as a sub-unit of the Centre for Quality Assurance, with the aim of popularizing the activities done by SUSL.
- vi. Director, CQA, participated to the international conference on "Qualification Frameworks & Recognition of Qualifications and Credentials in Higher Education held on 28-29 June 2023 in Colombo.
- vii. Dr. Upali Mampitya has officially retired as the advisor to the SSC-QA after serving as the external advisory member to SSCQA, SUSL for more than two years. Hence, Prof. Ranjith Pallegama, Director, CQA, University of Peradeniya has been appointed to serve as the new advisory external member to the SSCQA.
- viii. CQA has taken the steps to initiate the development of five years Strategic Management Plan (2024-2028) in line with the University Strategic Management Plan.
- ix. A committee is working for the development of the waste management policy and procedure for SUSL. In order to proceed with it, a waste quantification survey has been conducted by covering the entire university premises on 13th September, 2023.

The implementation of the ISO 9001:2015 QMS certification process is a continuous process which expanded over the years. We started the preparatory activities with initial awareness for FQAC steering committee members in the year 2020 and still continuing the process with the support of an external resource person, Mr. Ajith Prasanna, Head of Certifications, LAUGFS Holdings Limited. In parallel to the awareness sessions, the following tasks have been completed up to date.

- Obtained internal auditor training from Sri Lanka Standard Institute [SLSI] as a compulsory requirement of the implementation of the standard (5 Members from the Faculty)
- 2. Drafted the process map of FMS identifying key processes and connections between the processes (Version 01) Circulated among the staff members for comments (2021 to date)
- 3. Established quality objectives for QMS (Data requirements and responsibility sheet for calculating and determining baseline/s) Circulated for collecting required data
- 4. Drafted Master List of Documents (MLD) for QMS (2023)
- 5. Identified internally and externally originated documents to be collected for QMS Circulated for collecting required documents/records (2023)

Analysis Phase: 2022 - 2023


The innovation analysis commences with thoroughly examining the current process architecture within the Faculty of Management Studies. This involves scrutinising each operational aspect, from administrative procedures to academic frameworks, to identify inefficiencies, redundancies, and areas ripe for enhancement. A comprehensive understanding of the existing landscape is attained by employing tools such as process mapping, value stream analysis, and stakeholder consultations.

Implementation Strategy:

Upon completing the analysis phase, the focus shifts towards the strategic implementation of activities aimed at optimizing process architecture and improving overall quality. This entails a structured approach comprising the following steps:

- 1. Prioritisation of Activities:
 - a. Categorize identified improvement opportunities based on their potential impact and feasibility.
 - b. Allocate resources and set timelines for each activity to ensure a systematic approach to implementation.
- 2. Cross-Functional Collaboration:
 - a. Foster collaboration and communication among various departments and stakeholders to ensure a holistic approach to process enhancement.

- b. Establish interdisciplinary task forces to address complex challenges and drive collective problem-solving.
- 3. Pilot Testing and Iteration:
 - a. Implement proposed changes on a small scale through pilot projects or trials to gauge effectiveness and identify any unforeseen challenges.
 - b. Solicit feedback from end-users and stakeholders to refine processes iteratively and ensure alignment with expectations.
- 4. Training and Capacity Building:

Activity No. 4: Setting up of ISO 14001:2015 - Environmental Management System in FMS


4.1 Environmental performance monitoring systems established to support the implementation of ISO 14001:2015 EMS in the Faculty of Management Studies

As a requirement for implementing an Environmental Management System in the FMS in line with ISO14001:2015, the following web-based systems are established under the financial support of the AHEAD ELT ELSE Project. These systems are monitored and reported under the Sustainability Cell of FMS, one of the operational Cells under FQAC FMS.

1. We have established a Utility monitoring system to monitor sustainability performance in terms of electricity consumption, water consumption, and waste generation in the Faculty.

This component is linked to the FMS curriculum in EcoBusiness Management Degree programmes, specifically to the subjects of Energy & Industrial Resource Management [EBM 2253], Tools for Environmental Assessment [EBM 3152] and Sustainable Operations Management [EBM 3123], where students are expired to



engaged with monitoring activities as a part of their continuous assessments.






4.2 Established a Greenhouse Gas [GHG] Monitoring system to monitor GHG in the Faculty to support the implementation of ISO 14001:2015 EMS in the Faculty of Management Studies

Activity Coordination: Dr Sampath Wahala, Mr Chandimal Ranathunga, Ms Lavangi Bandara, Miss Shehara Jayakody, Ms Dimuthu Vijerathne

A GHG emission management system includes several processes and tools created by organisations to understand, measure, monitor, report, and validate their GHG emissions. Two of the most widely adopted frameworks for GHG inventory reporting are ISO 14064 and the GHG Protocol.

The faculty of Management Studies has started monitoring and reporting GHG in accordance with ISO 14064-1:2018 - Greenhouse gases Part 1: Specification with guidance at the organisation level for quantification and reporting of greenhouse gas emissions and removals.

GHG management is linked to the FMS curriculum in EcoBusiness Management Degree programmes, specifically to the subjects of Energy & Industrial Resource Management [EBM 2253], Environmental Footprint Management System Standards & Compliance Auditing [EBM 3133], and Industrial Ecology [EBM 3143], where students are required to engage with monitoring activities as part of their continuous assessments.



4.3 Established a Handmade Paper Recycling plant in the Faculty of Management Studies

This Handmade Recycling Plant was established under the financial support of the AHEAD ELT ELSE Project. The project aims to make handmade paper from waste paper collected in the university as a measure to manage the environmental burden of waste paper disposal to produce value-added marketable products as a real-world business model for students to learn and engage in to understand and operate a student-based business. The operations are coordinated by the Sustainability Cell of FMS, one of the operational Cells under FQAC FMS.

This project activity is linked to the FMS curriculum in all the Degree programmes the Faculty of Management Studies offers. It creates a miniature production facility that mimics all the real-world operations of a production facility, from material supply to sales of the final product, with value addition. This project activities are linked explicitly to the subjects of Modelling EcoBusiness [EBM 4152], Industrial Operations in the Manufacturing Sector (Elective) [EBM 4172] Energy & Industrial Resource Management [EBM 2253], Environmental Footprint Management System Standards & Compliance Auditing [EBM 3133] and Industrial Ecology [EBM 3143], Green Supply Chain Management [EBM 3172] etc. where students are expired to engaged with monitoring activities as a part of their continuous assessments.







Activity No. 5: Student Mini projects encouraging Student-Centred Learning (SCL) in FMS

5.1 Student mini projects in change management - BM 4142

Activity Coordination: Miss Waruni Thiranagama (Lecturer in charge)

At the Faculty of Management Studies (FMS), change is not just a theoretical concept; it is a force initiated and championed by our very own students. Over the past semester, final students in the Department of Business Management relevant to the Change Management [BM 4142] course have taken the reins of progress, identifying crucial areas for improvement and implementing transformative mini-projects within the Faculty. Under the guidance of Ms A.W. Thiranagama, Subject Lecturer, and Dr. W.M.P.S.B. Wahala, Coordinator of the Faculty Quality Assurance Cell, these young change agents have left an indelible mark on our faculty, bringing about positive and tangible outcomes as mentioned below [Time Frame: May – June 2023].



1. Sustainable Solutions: Establishing a Collecting Point for Used Empty Pens

One of the initial endeavours that gained momentum in the Student Mini Projects in Change Management was establishing a collecting point for used empty pens. Students recognized the presence of discarded pens contributing to environmental waste. With a vision of sustainability, they decided to collect these pens and send them for refilling, effectively reducing the environmental impact on our faculty. This initiative not only encourages responsible consumption but also fosters a sense of environmental stewardship among the FMS community.

2. Enhancing Student Washroom Facilities: A Step Towards Inclusivity

Empathy lies at the heart of change, and our students exemplified this through two vital projects aimed at improving washroom facilities for everyone. Firstly, they installed bag racks outside the student washrooms, alleviating the inconvenience of carrying belongings inside. Secondly, acknowledging the importance of menstrual hygiene, they introduced a refilling sanitary pad box in the female student washroom. These thoughtful initiatives contribute to a more inclusive and supportive environment for all members of the FMS community.

Project Management is considered to be one of the significant and most wanted roles in the business world. Hence, this subject is developed in a way to cater both theoretical and practical aspects by conducting in class lectures and guiding the student to think critically from planning to the completion of a project. As a partial fulfilment of the subject Project management EBM 4132 students were guided to develop creative project ideas relevant to their field of study. As a result, the following projects were conducted by the 4th year Undergraduates.

1. Upcycled Field Books

As global pulp and paper consumption is increasing day by day, the amount of paper waste and the careless use of paper leads to deforestation. Currently, in each Department of the Faculty of Management Studies, single-sided used papers have been piled up without being used again. As we as in the undergraduates' hostels, a significant amount of single-used papers is being piled up without reuse. Hence, this group decided to upcycle the waste paper by converting it into mini notebooks (field books). This project also generated income by selling the upcycled filed books to the



faculty's undergraduates.

2. Eco Cover for the Generator

In the Faculty of Management Studies, a few critical emission points have an adverse effect on the environment. Among those points, the faculty power generator significantly contributes to GHG emissions by emitting carbon dioxide (CO2) and other polluting gases and generating noise and considerable heat around the generator. To reduce the impact, this project group built an Eco cover for the generator by planting a few types of liana, as they have the ability to prevent radiating heat more and with the expectation of creating a barrier to the noise generation. This initiation enabled the sequestration of some carbon dioxide released by the generator fuel burning, which will minimise the contribution to global warming. In addition, this eco cover acts as a beautiful background for the faculty generator.








3. Faculty Vertical Green Wall





Activity No. 6: Faculty – Industry collaborative projects on Outcome Based Education (OBE) to improve the quality of teaching and learning

6.1 Jay Jay Mills Cleaner Production Assessment

Bridging faculty and the industry through different collaborations is one of the key strategies of the Faculty of Management Studies. The expectations of such collaborations are multiplefold. The main aim of these engagements is to set the ground for our undergraduates to apply theoretical concepts in real environments where they will experience and overcome different challenges. Providing networking opportunities with industry professionals, exposing them to professional establishments, and opening career opportunities are the other key objectives of such engagements.

Given the above objectives, a comprehensive Cleaner Production Assessment was conducted for ten Jay Jay Jay Mills Lanka Group production facilities in operation in Avissawella, Mannar, Trincomalee, Monaragala, and Matara between June 2022 and June 2023. Students submitted their observations and the assessment findings to the Jay Jay

group through reports, which were then followed by a finding presentation session.

The project not only gave the students practical experience related to the subject module on Resource Efficient Cleaner Production [EBM 3213] but also was a learning package covering other modules. Students had the opportunity to connect many of the learning modules they undertook at the university. Upon completion of the project, a few students were able to join the JJM as interns to complete their final year internship program.



7.2 Training on ISO/IEC 17024:2012 - Conformity assessment, General requirements for bodies operating certification of persons

ISO/IEC 17024:2012 contains principles and requirements for a body certifying persons against specific requirements and includes the development and maintenance of a certification scheme for persons.

This International Standard specifies requirements which ensure that certification bodies for persons operating certification schemes for persons operate in a consistent, comparable and reliable manner. The requirements in this International Standard are considered to be general requirements for bodies providing certification of persons. Person certification can only occur when there is a certification scheme. The certification scheme is designed to supplement the requirements included in this International Standard and includes those requirements that the market needs or desires or that are required by governments.
