Programme Reviews (PR) in State Universities - 2017

The University Grants Commission has decided to conduct PR in State Universities on the basis of clustering related programs at Faculty level.

Hence, considering the priority requirements and guidance of the Accelerating Higher Education Expansion & Development (AHEAD) program, Study Programs conferring Bachelor of Arts degrees in Faculties of Arts, Social Sciences and Humanities was recommended and approved by the Commission at its 956th meeting held on 5th January 2017, as the first cluster of degree programs to be reviewed in year 2017.

Bachelor of Education and Bachelor of Law, in the above Faculties would not be considered for the first cluster.

The cost structures and budgets for reviews will be applied according to the Circular letter UGC/ QAAC/ IR/01.
