#### Overview

Mission and goals of the Sabaragamuwa University of Sri Lanka are set for producing quality graduates who cater the national and international demands. As the University is one of the higher educational institutes of the country which uses state funds, the university has responsibility of producing graduate suit to the needs of the country. Therefore, the education provision in the university must align with the national policies.

## **Purpose**

As the University is a government funding agency, it is required to liaise its all the activities with the legal acts, establishment codes, rules, regulations, national policy framework and strategies. Therefore, the University should give strong directions to adapt or liaise with all the regulatory/ national policy frameworks.

### Scope

Legal Acts, establishment codes, rules, regulations, national policy framework and strategies are integrated within the governance and management of the University. Hence this policy shall

apply to all the administrators of the University/officers, all statuary bodies, committees, all the staff and the students of SUSL.

## **Policy Statement**

- 01. University should be committed to comply with national policies, regulations, and guidelines prescribed by regulatory agencies without compromising the academic integrity of the institution.
- 02. SUSL should set own policies, By- Laws in comply with the national policies as relevant to the vision and the mission of the University.
- 03. SUSL shall develop and implement its policies By-Laws, Frameworks targeting the Sustainable Development Goals (SDG)s as set forth by the Democratic Socialist Republic of Sri Lanka to ensure the socio economic development of the country.
- 04. The university shall develop the strategic plan /corporate plan /action plan in compliance with National Higher Education Policy Framework and other guidelines of MoHE (Ministry of Higher Education), University Grants Commission (UGC) and QAC (Quality Assurance Council).
- 05. The University shall consider the strategic plan of the UGC when developing its strategic plan, action plan, policies, By Laws, guidelines and etc.
- 06. SUSL shall promote research, development and innovation in line with the national policy framework / rules / regulations/ SDGs
- 07. Whole University community must aware on the necessity of following relevant national level policies, rules, regulations and also the UGC imposed rules, regulation or laws. It is not possible to cross the national level rules and regulations when developing any policy or governing documents.
- 08. When the University develops any policy, By-Law or guideline to encourage the local and international partnership, it should focus on the country's requirement and legal frame work as well as the SDGs.
- 09. University shall review the policies, Bylaws and other documents in used for their compatibility with the changing national policies and other rules and regulations.
- 10. This Policy should be evaluated periodically and it can be amended with the recommendation of the Senate Standing Committee on QA and followed by the Senate

and Council approval (See the Policy on formulating and regulating policies of SUSL, Policy / SUSL / Gov & Mgmt / 14 – Annex 2)
