Ltd, Mr. K. Wanigasekara, Assistant Manager – Hayleys Agro Farms Pvt. Ltd and the Manager of the University Business Linkage Cell. On behalf of the Sabaragamuwa University of Sri Lanka the agreement was signed by the Vice-Chancellor and Director of Hayleys Agriculture Holdings Ltd. signed the agreement from the company end.

The objective of this project is to identify suitable potato varieties that fulfils required physico-chemical and morphological characteristics for the production of value-added potatoes such as potato chips, French fries, potato wedges etc. using local potato varieties to approach the local and international market. The project will be continuing under the guidance and supervision of Faculty of Agricultural Sciences and Faculty of Applied sciences and Hayleys will support in the financial aspect in order to get a fruitful result from this research project.

ERASMUS

Sport and Physical Education as a Vehicle for Inclusion and Recognition in India, Indonesia and Sri Lanka

The Sabaragamuwa University of Sri Lanka partnered with the University of Peradeniya to create a modular program in Sri Lanka in sport, physical education and health sciences that will contribute to increase the recognition of the fundamental value of sport and physical activity for the individual and society.

The Erasmus plus (+) project is led by the European Commission with the consortium of 12 universities to research Sports Education in India, Sri Lanka and Indonesia. The motive behind the project is for capacity building in the field of sports, physiotherapy and physical education through research and community development. The European Union's Erasmus+ plus program is a funding scheme to support activities in the fields of education, training, youth and sport. Erasmus+ funds academic mobility and cooperation projects that involve partners from "Partner Countries" throughout the world.

Memorandum of Understanding (MoU) was signed virtually due to the prevailing COVID19 situation. The Professor Udaya Rathnayaka, Vice-Chancellor signed the MOU on behalf of the Sabaragamuwa University of Sri Lanka and Dr. Rasangi Sabaragamuwa, the Dean of the Faculty of Applied Sciences graced the occasion.

Mrs Thanuja Liyanage, Lecturer of the Department of Sports Sciences and Physical Education (SSPE) serves as the manager of the project, Mrs Harshani Perera, Head of the Department of SSPE, Professor Kapila Rathnayaka, Mrs Lakshika Madhushani, Mrs Deepanjali Weerarathna, Mr Sameera Lakruwan Perera, Mrs Milani Jayasinghe, Mrs Mangala Samarakoon, Mr L Sarmilan, Mr Kasun Kalana and Mr Udaya Herath are in the project team along with Mrs Geethani Rajapaksha as the project secretary.

The project will address the issues of inclusion, diversity and integration of vulnerable groups and students with special needs through sport and physical education as well. The project expects to develop a multidisciplinary approach in education, sport and health sciences in line with Bologna standards that promotes inclusive education and correct nutrition through modular courses, lifelong



learning programs and sports events. The project will further facilitate to create a modular programme in Sport, physical education and Health Sciences in 3 countries of Asia that contribute to increase the recognition of the fundamental value of sport and physical activity for the individual and society, well beyond competition, as a powerful tool for the promotion of healthy lifestyles and socioeconomic development - putting special emphasis in vulnerable groups, female and students with special needs.

LICENSE AGREEMENT

The official ceremony was held on 15th February 2021 at the board room of the Vice Chancellor's office of the University with the presence of the Vice-Chancellor of Sabaragamuwa University of Sri Lanka, Director and Manager of University Business Linkage Cell, Managing Director and Deputy General Manager of Food & Nature Pvt. Ltd and the research team of the Faculty of Applied Sciences.

Achieving the main motive of the event, a licensing agreement was signed giving an exclusive right to FADNA to commercialize an herbal low glycemic tea formulation developed by the research team of the Faculty of Applied Sciences, Sabaragamuwa University of Sri Lanka. This product was especially developed as a healthy tea for people with diabetes mellitus and the research was funded by the Research Innovation and Commercialization (RIC) grant of the Accelerating Higher Education Expansion and Development (AHEAD) program. The "Diabe tea" was launched on 4th September 2020 and commercialized liaising with Food and Nature (Pvt.) Limited under the brand name FADNA.

Diabetes mellitus (DM) is a non-communicable disease and has become one of the leading health problems globally due the severe complications associated with it. Sri Lankan population has over 10% diabetes prevalence, and prevalence of pre-diabetes is 11.5%, which implies that its prevention and management is crucial to build a healthy nation. By addressing this emerging need Sabaragamuwa University of Sri Lanka, RIC team of Faculty of Applied Sciences, has developed several herbal formulations with anti-diabetic properties and has incorporated into food products.

This is 100% natural herbal combination in which the hypoglycemic effect, efficacy levels and the safety of the products was confirmed by in vitro and in vivo assays (target-based and cell-based bioassays) followed by animal and clinical trials, thus providing scientific validation to the indicated health claims, consequently, going in-line with the global regulatory framework. This product includes readily accessible nutraceutical formulations and also functional food products satisfying both health and wellness as well as consumer acceptance with the focus of 'con-



sumer-friendly, flexible enough for everyday use' concept. Main herbal ingredients and their composition are not previously reported elsewhere in any herbal formulation currently available in the market (locally or internationally) for the treatment/control/prevention of DM or DM associated ailments. Therefore, an upfront payment and royalty payment will be made upon for the product valuation and SUSL shall be compensated by FADNA as agreed by the both parties. This partnership will be continued for a period of fifteen years and this will remain as one of the praiseworthy efforts of the university business linkage cell in the history.
