**(1) LECTURER (PROBATIONARY) (Medical/Dental)**

(based on UGC Cir. 721, 935 , 08/2016, 08/2016 (ii), 08/2016 (iii) and 16/2017)

Qualifications:

- (1). MBBS/BDS Degree with First or Second Class (Upper Division); A candidate who has obtained a First or Second Class (Upper Division) in the 2<sup>nd</sup>(Introductory Basic Sciences Stream) or the 3<sup>rd</sup>(Applied Sciences Stream) MBBS examination and passed the final MBBS examination may also be considered where recruitment is for pre-clinical or Para-clinical subjects;

**OR**

- (2). MBBS/BDS Degree with Second Class (Lower Division); A candidate who has obtained a Second Class (Lower Division) in the 2<sup>nd</sup> (Introductory Basic Sciences Stream) or the 3<sup>rd</sup>(Applied Sciences Stream) MBBS examination and passed the final MBBS examination may also be considered where recruitment is for pre-clinical or Para-clinical subjects;

**OR**

- (3). MBBS/BDS Degree and, a Masters Degree in the relevant field with full time research of at least 24 months duration or a Doctoral Degree or MD/MS and Board Certification by the Postgraduate Institute of Medicine where required or its equivalent.

**OR**

- (4). Such academic or professional qualifications or professional experience as may be approved by the University Grants Commission upon the recommendation of the Higher Educational Institution concerned.

**Salary Scale:** Rs. 94,400 – 10 x 2,400 – 118,400 p.m. [U-AC 3 (IV) - 2025]

**Notes :**

- (a) (i) Candidates who are eligible under category (1) above will be interviewed and evaluated first.
- (ii) Candidates who are eligible under category (2) & (3) above could be invited for an interview only if applicants qualified under category (1) above are either not available or found to be unsuitable by the Selection Committee after interview and evaluation. Appointment of candidates under categories (2) and (3) would require the approval of the University Grants Commission.
- (iii) Candidates eligible under category (4) above will be invited for an interview only if there are no suitable candidates under categories (1), (2) and (3).



Appointment of a candidate under category (4) requires the approval of the University Grants Commission.

- (b) Where MBBS Degree is awarded with Second Class Honors without designating Division (Upper/Lower), the Selection Committee shall determine the equivalent Division by scrutinizing the transcripts of candidates.
- (c) All candidates required to make a presentation before the Selection Committee in order to prove their teaching ability as a Lecturer (Probationary).
- (d) The eligibility of non- (Medical /Dental) graduates for appointment to positions in the Faculties of Medical/Dental Sciences will be determined on the basis of qualifications prescribed for non- (Medical /Dental) appointments.

**(2) LECTURER (UNCONFIRMED) (Medical/Dental)**

(based on UGC Cir. 721, 935 , 08/2016, 08/2016 (ii), 08/2016 (iii),16/2017 and 07/2018)

Qualifications:

- (1) Candidates shall possess the academic qualification required for **Lecturer (Probationary)[Medical/ Dental]**as specified above.

**AND**

- (2) A MD/MS & awaiting Board Certification of the Postgraduate Institute of Medicine (PGIM) or a Masters [as defined in 3 (b) (ii) of Commission Circular No.08/2016] or a Doctoral Degree, in the relevant field.

**Salary Scale:** Rs. 121,340 – 5 x 2,940 – 136,040 p.m. [U-AC 3 (III) – 2025]

*Notes:*

- (a) A applicant who qualifies for Lecturer (Probationary) (Medical/Dental) as per category (03) of Post No. 01 of Commission Circular No. 721 as amended, may be exempted from (2) above if he/she has a MD/MS & Board Certification of the PGIM or a Doctoral Degree, in the relevant field.
- (b) An applicant who qualifies for Lecturer (Probationary) (Medical/Dental) as per category (03) of Post No. 01 of Commission Circular No. 721 as amended, and has a MD/MS & awaiting Board Certification of the PGIM or a Masters Degree (as defined in 3(b) (ii) of Commission Circular No. 08/2016 in the relevant field, may be exempted from (2) above if he/she has evaluated research and dissemination of knowledge for a minimum total of 15 marks. The section 2 Research & Creative Work) and sub-section 3.1 (Dissemination of Knowledge) of the Marking Scheme for the posts of Associate Professor/Professor should be used for this purpose.
- (c) All candidates required to make a presentation before the Selection Committee in order to prove their teaching ability as a Lecturer (Unconfirmed).





### Special Notes :

1. A Lecturer (Unconfirmed) (Medical/Dental), who has completed the three year period of satisfactory service and the induction training course within a period of one year from the date of appointment and also obtained Board Certification of the PGIM, may be confirmed in the post of Lecturer (Medical/Dental), provided such Lecturer has fulfilled all other requirements specified in the letter of appointment.
2. The confirmed Lecturer (Medical/Dental) may be considered for promotion to Senior Lecturer Grade II upon fulfilling 5 years of experience (along with the experience as defined under (3) Post No. 04) and satisfying the other requirements as specified in the Scheme of Recruitment under Post No. 05 of Commission Circular No. 721.
3. The effective date of the promotion to the post of Senior Lecturer Grade II of only those appointed as Lecturer (Unconfirmed) (Medical/Dental) based on a MD/Doctoral degree, may be backdated to the effective date of Board Certification of the PGIM or to the date on which they have completed 6 years of experience as per Post No. 04, whichever occurs later, as applicable, by placing them on the relevant salary step, with no back wages being paid.

### **(3) SENIOR LECTURER GRADE II (Medical/Dental)**

(based on UGC Cir. 721, 935 , 08/2016, 08/2016 (ii), 08/2016 (iii) and 16/2017)

#### Qualifications:

- (1) Candidates shall possess the academic qualification required for **Lecturer (Probationary)[Medical/ Dental]** as specified above.

AND

- (2)
  - (i). A Masters Degree in the relevant field with full time research of at least 24 months duration or a Doctoral Degree or MD/MS and Board Certification by the Postgraduate Institute of Medicine where required or its equivalent.

OR

- (ii). Such professional qualifications and experience as may be approved by the University Grants Commission upon the recommendation of the Higher Educational Institution.

AND

- (3) At least six (06) years of experience in one or more of the following:
  - i. Teaching at University level,
  - ii. Professional Experience,
  - iii. Research in a recognized Institution,
  - iv. Postgraduate Studies to acquire the qualifications stipulated at (2.) above

(based on UGC Cir. 721, 935 , 08/2016, 08/2016 (ii), 08/2016 (iii) and 16/2017)

Qualifications:

- (1) Candidates shall possess the academic qualification required for **Lecturer (Probationary)[Medical/ Dental]** as specified above.

AND

- (2) (i). A Masters Degree in the relevant field with full time research of at least 24 months duration or a Doctoral Degree or MD/MS and Board Certification by the Postgraduate Institute of Medicine where required or its equivalent.

OR

- (ii). Such professional qualifications and experience as may be approved by the University Grants Commission upon the recommendation of the Higher Educational Institution.

AND

- (3) At least eleven (11) years of experience {of which not less than six (06) years should have been after obtaining the qualifications stipulated in 2 above} in one or more of the following :

- i. Teaching at University Level,
- ii. Professional Experience,
- iii. Research in a recognized Institution,
- iv. Postgraduate Studies

- (5) **LECTURER (PROBATIONARY) [Non-(Medical/Dental)]**  
(based on UGC Cir. 721, 935, 08/2016, 08/2016 (ii), 08/2016 (iii))

**Qualifications**

- (1) A Degree with specialization in the relevant subject with First or Second Class (Upper Division) Honors.

OR

- (2) A Degree with specialization in the relevant subject with Second Class (Lower Division) Honors.

OR

- (3) A Degree with specialization in the relevant subject without Honors or any other degree with at least Second Class Honors,



AND

- (a) (i) A Doctoral Degree in the relevant field

OR

- (ii) A Masters Degree in the relevant field obtained after a full-time course of study of at least 24 months duration (or an equivalent part-time course of study) with a research component by way of thesis/ dissertation.

OR

- (iii) A full time Masters degree in the relevant field of a minimum of 18 months duration with at least 60 credits\* of which not less than 15 credits\* of research by way of thesis/ dissertation.

[\* One credit considered per course unit/module should be in accordance with the Sri Lanka Qualifications Framework (SLQF)]

- (b) In the case of Faculties of Science/ Applied Science/ Engineering/ Agriculture/ Technology

- (i) A Doctoral Degree in the relevant field.

OR

**Special Note:**

All Lecturers (Probationary) shall complete an induction training course (which includes Teaching/Learning Methodologies) within a period of one year from the date of first appointment. This is a pre-requisite for probationary study leave and confirmation in the post. The University Grants Commission will organize this course of training twice a year, i.e.: December/January and June / July.



(6) **LECTURER (UNCONFIRMED) [Non-(Medical/Dental)]**

(based on UGC Cir. 721,935,08/2016, 08/2016 (ii), 08/2016 (iii) and 07/2018)

**Qualifications:**

- (1) Candidates shall possess the academic qualifications required for Lecturer (Probationary) [Non-(Medical/Dental)] as per category (1) or (2) of POST 01 of Commission Circular No. 721 as amended.

**AND**

- (2) A Master's Degree (as specified in para. 3 of Commission Circular No.08/2016) or Doctoral Degree, in the relevant field (but, less than 06 years of experience as specified in the Scheme of Recruitment for Senior Lecturer Grade II, by open advertisement, given in POST 6 of Commission Circular No. 721 as amended).

**Salary Scale:** 121,340 – 5 x 2,940 – 136,040 p.m. [U-AC 3 (III) – 2025]

**Notes:**

- (a) An applicant who qualifies for Lecturer (Probationary) [Non-(Medical/Dental)] as per category (3) of Post No. 02 of Commission Circular No. 721 as amended, but less than 06 years of experience as specified in the Scheme of Recruitment for Senior Lecturer Grade II, by open advertisement, given in POST 6 of Commission Circular No. 721, may be exempted from (2) above if he/she has a Doctoral Degree in the relevant field.
- (b) An applicant who qualifies for Lecturer (Probationary) [ Non-(Medical/Dental)] as per category (3) of Post No. 02 of Commission Circular No. 721 as amended, and has a Master's Degree (as specified in para. 3 of Commission Circular No. 08/2016) but less than 06 years of experience as specified in the Scheme of Recruitment for Senior Lecturer Grade II, by open advertisement, given in POST 6 of Commission Circular No. 721 as amended, may be exempted from above (2) if he/she has evaluated research and dissemination of knowledge for a minimum total of 15 marks. The section 2 and subsection 3.1 of the Marking Scheme for the posts of Associate Professor/Professor should be used for this purpose.
- (c) All candidates required to make a presentation before the Selection Committee in order to prove their teaching ability as a Lecturer (Unconfirmed).

**Special Notes:**

1. A Lecturer (Unconfirmed) [ Non-(Medical/Dental)], who has completed the three year period of satisfactory service and the induction training course within a period of one year from the date of appointment, may be confirmed in the post of Lecturer [ Non-(Medical/Dental) ], provided such Lecturer has fulfilled all other requirements specified in the letter of appointment.
2. The confirmed Lecturer [Non-(Medical/Dental)] may be considered for promotion to Senior Lecturer Grade II [ Non-(Medical/Dental) ] upon fulfilling 5 years of experience (along with the experience as defined under Post No. 06) and satisfying the other requirements as specified in the Scheme of Recruitment under POST 07 of Commission Circular No. 721.



3. The effective date of the promotion to the post of Senior Lecturer Grade II of only those appointed as Lecturer (Unconfirmed) [Non-(Medical/Dental)] based on a Doctoral degree, may be backdated to the date on which they have completed 6 years of experience as per POST 06, by placing them on the relevant salary step, with no back wages being paid.

(7) **SENIOR LECTURER GR. II [Non-(Medical/Dental)]**

(based on UGC Cir. 721, 935, 08/2016, 08/2016 (ii), 08/2016 (iii))

**Qualifications:**

- (1) Candidates shall possess the academic qualifications required for Lecturer (Probationary) [Non-(Medical/Dental)] as specified in this document. (Under POST 2 of UGC Cir. 721. (*Annex 01*))

**AND**

- (2) (i) [a] (i) A Doctoral Degree in the relevant field

**OR**

- (ii) A Masters Degree in the relevant field obtained after a full-time course of study of at least 24 months duration (or an equivalent part-time course of study) with a research component by way of thesis/ dissertation.

**OR**

- (iii) A full time Masters degree in the relevant field of a minimum of 18months duration with at least 60 credits \* of which not less than 15credits\* of research by way of thesis/ dissertation.

[\* One credit considered per course unit/module should be in accordance with the Sri Lanka Qualifications Framework (SLQF)]

[b] In the case of Faculties of Science/Applied Science/ Engineering/ Agriculture/ Technology

- (i) A Doctoral Degree in the relevant field.

**OR**

- (ii) A Masters Degree in the relevant field with full time research of at least 24 months duration

**OR**

- (1) Candidates should possess the academic qualifications required for Lecturer(Probationary) Non- (Medical/Dental) as specified in this document. (under POST 2 of UGC Cir. 721. (*Annex 01*))

**AND**

- (2) (i) [a] (i) A Doctoral Degree in the relevant field

**OR**

- (ii) A Masters Degree in the relevant field obtained after a full-time course of study of at least 24 months duration (or an equivalent part-time course of study) with a research component by way of thesis/ dissertation.

**OR**

- (iii) A full time Masters degree in the relevant field of a minimum of 18months duration with at least 60 credits \* of which not less than 15 credits\* of research by way of thesis/ dissertation.

[\* One credit considered per course unit/module should be in accordance with the Sri Lanka Qualifications Framework (SLQF)]



[b] In the case of Faculties of Science/ Applied Science/ Engineering/ Agriculture/Technology

(i) A Doctoral Degree in the relevant field.

Notes: (a) An applicant who is eligible under (3) above could be considered for appointment only if no applicant/s qualified under (1) or (2) above is available.

(b) An applicant who is eligible under (2) above could be considered for appointment only if no applicant/s qualified under (1) above is available.


